*(Applicable for direct recruitment but age will be relaxed in case of Promotion)*

**i) ESSENTIAL:**

- a) degree in Ayurved from a University established by law or a statutory Board/ Faculty/Examining Body of Indian Medicine or its equivalent as recognized under Indian Medicine Central Council Act, 1970.
- b) A Post-graduate qualification in the subject/specialty concerned included in the schedule to Indian Medicine Central Council Act, 1970.

**ii) EXPERIENCE:**

- a) **For the Post of Professor:** Total teaching experience of **ten** years in concerned subject is necessary out of which there should be **five** years teaching experience as Reader/ Associate Professor in concerned subject.

**b) For the Post of Associate Professor (Reader):**

Teaching experience of **five** years in concerned subject. (Reader will be treated as Associate Professor).

- c) **For the Post of Asst. Professor ( Lecturer):** *with the age not exceeding forty-five years, no* teaching experience is required. Lecturer will be treated as Assistant Professor.

**d) Qualification for the Post of Head of Institution (Principal/Dean/Director):**

The qualification and experience prescribed for the Post of Professor shall be essential for these posts.
